SCE assists in new PPL Power Line project.

On the promise of reinforcing "our nation's critical energy infrastructure for future generations," PPL Electric Utilities of Pennsylvania and Public Service Electric and Gas Co. of New Jersey, have begun the installation of a 145-mile, 500-kilovolt power line to run from Berwick, PA to Roseland, NJ. About 95% of the route follows the path of an existing and outdated power line that has been in place for over 80 years. SCE joined the team with primary responsibility of removing hundreds of old transmission towers coated in lead paint.

The project, which involved shearing nearly 300 towers into transportable pieces, required the careful handling of lead-based paints with constant air-quality monitoring and dust control. Sheets of protective plastic lined the ground as SCE technicians worked hand in hand with helicopter crews to drop the towers. Next, the towers were dismantled, sheared and shipped for proper disposal. SCE's first portion of the project, under the supervision of Foreman Mike Dahlgren, finished on schedule and with no injuries.

EPA Certifies SCE for Lead Abatement.

Adding to its repertoire of certifications and licenses, SCE has qualified as a U.S. EPA Lead-



Safe Certified Firm. This designation authorizes the company to undertake Reno-

vation, Repair and Painting Activities in EPA-regulated states. In addition, the company has received similar certification from the EPA for lead abatement activities.

SCE Undertakes Slurry Wall Project in NY



SCE has mobilized and begun work on a deep soil mix (DSM) slurry wall project in Port Jervis, NY. The project site is a municipally-owned parcel situated at the northern corner of the City's downtown Central Business District. One of the more notable features of the project site is the Erie Turntable, one of the last remaining turntables in the northeast. The primary purpose of this 13,500 SF slurry wall is to control the petroleum plume from migrating off-site.

Progress was challenged when digging uncovered extremely large boulders rendering normal excavation techniques ineffective. SCE's solution was to design a seven-foot, 4,000 lb solid steel ripper tooth that attached to a Caterpillar 349E Excavator. The ripper tooth was designed, fabricated, mounted and on-site in less than 48 hours.

Work continues through October.

SCE Supports Local Police

SCE is pleased to support the Archbald Pennsylvania Police Department and Chief Tim Trently with the donation of an iPad tablet PC. The iPad will allow officers to check for warrants quickly, search the Web, and use software applications for language translation, mapping, and tracking stolen property.

"These capabilities will aid the Archbald police in protecting their citizens," SCE's President, Jody Cordaro, said. SCE made the gift after a recent conversation

with Police Chief Trently, who told them that the department has been hoping to adopt more crime-fighting technology but was lacking the funding to get the iPads.

Chief Trently said, "For officers who are on their way to a crime scene, iPads can give advanced notification and much more detail about the situation than they've ever had before, and they can give information on people in



that area, as well. The technological advantages of having an iPad are tremendous."

Compared with laptop computers that are typically mounted inside police cruisers, iPads are faster, simpler to use, and less expensive to maintain and buy. Also, iPads come with added features, such as the ability to take photos and videos. "SCE has been using tablet PC's for over a year on all of our projects throughout the US and it has changed the way we do business. With regard to this donation, the issue is really what we can

do as a community to help make the jobs of public safety officials easier," Cordaro noted.

This system will be used on job sites for random safety audits, client monitoring, and overall job site safety and security. Once tested, SCE will roll out CCTV systems on the entire fleet along with GPS tracking systems for all vehicles and heavy equipment.

To keep up with increased personnel, the corporate IT network, parking and storage areas got a boost as well.


The project is slated to complete in early October.

New Contracts in 3Q top \$4MM.

In a busy bidding season, SCE lands several notable projects from Puerto Rico to the World Trade Center Site.

Roosevelt Roads Naval Station.

SCE has been awarded a large demolition and remediation project in Ceiba, Puerto Rico. The Roosevelt Roads Naval Station is a former United States Navy base in the town of Ceiba, Puerto Rico. As part of the Navy's Base Realignment and Closure (BRAC) Program, this 2,900 acre property is part of a plan to convert the former military base into a civil airport. SCE's work will commence soon and will last several months.

World Trade Center Site.

Tn addition, the company was re-Leently advised by the NY/NJ Port Authority that it has received a preliminary award for the World Trade Center - Asbestos, Lead and Universal Waste Abatement contract. The scope of work includes demolition of concrete and asphalt pavement, the installation of temporary power and lighting, the removal and disposal of asbestos, and asbestos-containing materials, the removal and disposal of lead, lead-containing and lead contaminated material and the removal and disposal of universal wastes. This \$1.5MM contract will commence in November 2013 and have a duration of two (2) years.

Other Awards.

Complimenting this group of high-profile awards, the company also has received the go-ahead on many other projects including a remediation system install in one of New York's five Burroughs, and a bioslurp remediation in Linden, New Jersey. Ongoing contracts with the Pennsylvania Department of Environmental continue to generate additional projects, as well.

"Our staff additions have had a dramatic impact on the quantity of quality bids we can produce," says Jody Cordaro. "We are now able to estimate more bids on a wider variety of projects - a trend that we will foster and expand in the future."
